



Announcement of Ratburana District Office  
Subject The Intention of Administration with Honesty, Transparency and Verifiability

In accordance with the intention of the Constitution of the Kingdom of Thailand B.E.2560, the Act of Official Information B.E.2540, the Royal Decree on Good Government Administration Principles and Procedures B.E.2546, the National Strategy on Corruption Prevention and Suppression Phase 3, B.E.2560 - 2564 and the Government Policies Article 10, on Promotion of Public Administration with Good Governance, Corruption and Misconduct Prevention in the Public Sector, indicated to foster values, morals, ethics and consciousness in maintaining the honor of government officers and honesty along with effective public management to prevent and suppress corruption and misconduct of government officials at all levels, and respond the needs as well as facilitate to people to build confidence in that bureaucratic system.

Ratburana District Office has operated following the moral and transparency policy without corruption to be a standard, guidelines and values for government officers and staffs in performing along with other rules and regulations. By aimed to lead the department to carry out the mission with transparency, manage with honesty, morality, without corruption to achieve those intentions. Therefore, the government officers and staffs under Ratburana District Office, should behave and proceed as follows;

1. Administrate and perform according to good governance.

1.1 The department leaders focus on the assignment and the performance according to the mission, duties and responsibilities with fairness and equality, without discrimination.

1.2 Every department in Ratburana District Office must operate with transparency and verifiability by adhering to the principles of honesty, accuracy, and according to the law strictly.

1.3 Give importance to the disclosure of information of the department with transparency, adhering to principles of honesty, justice, accuracy, verifiable in accordance with the provisions of law.

1.4 All parties in Ratburana District Office must provide opportunities for people, service recipients and stakeholders to participate in the operations of the agency by adhering to the principles of honesty, transparency and fairness.

2. Cultivate values to have knowledge and understand, adhere to the principles of morality and ethics, apply the principles of the sufficiency economy philosophy in working and living create an organizational culture to stimulate the government officers and staffs in Ratburana District Office to have a conscience that does not tolerate corruption, ashamed and afraid of Corruption, Concern on the principles of accuracy, in accordance with the Disciplines of the Bangkok's Government Officers and the Bangkok 's Government Officers and Personnel Regulations Act B.E. 2554

3. Operate the procurement with transparency in all steps and provide opportunities to all sectors to participate in the decision.

3.1 Budget management by adhering to the principles of accuracy, discipline, transparency, verifiability, worthiness, and the highest benefit.

3.2 Stakeholders in all step and the people who are interested participate in the operation of the procurement process by adhering to the principles of law, discipline, transparency, verifiability and fairness.

3.3 There is the disclosure of information about the procurement operation with transparency through the official website and public relations board.

4. Prevent seeking of personal or others benefits.

4.1 The government officers and staffs in Ratburana District Office operate following the anti-corruption plan to prevent conflicts of interest in the organization

4.2 Perform according to standards / operation manuals by adhering to the principles of law and regulations with honesty transparency, verifiability and fairness.

5. Publicize to the people to inform the fraudulent clues and complaints

5.1 There are public relations to inform about complaints, grievances, and news of fraudulent clues, such as 1555 hotline, the official Line and website

5.2 There is a channel to complain, inform about the news and fraudulent clues directly ie. notifying the administrative officer or public relations department

6. Actions of corruption case

In case of fraud found, the investigating process is conducted and the maximum punishment against culprits, both civil and criminal cases.
